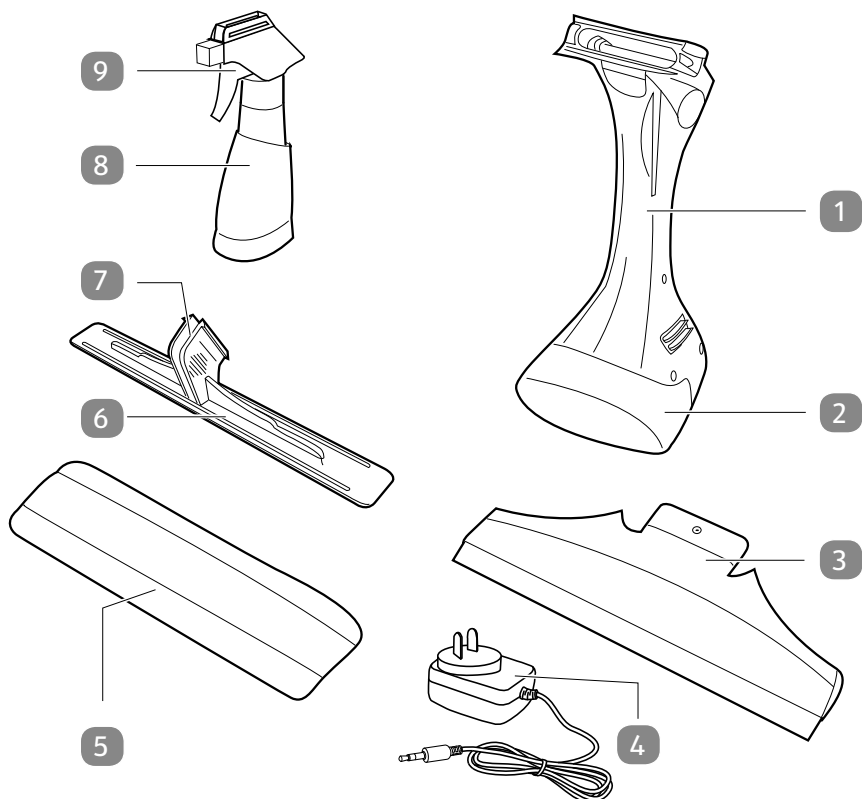

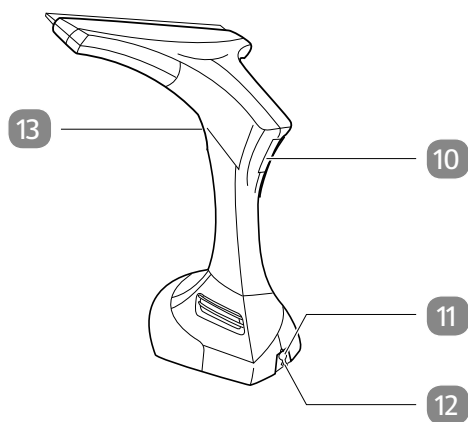

General information

Reading and storing the user manual



This user manual accompanies the handheld window vac cleaner. It contains important information on start-up and handling.

For improved readability, the handheld window vac cleaner will be referred to only as the window cleaner below.

Before using the window cleaner, read the user manual carefully. This particularly applies to the safety notes. Failure to heed this user manual may result in severe injury or damage to the window cleaner.

Keep the user manual for future use. If you pass the window cleaner on to third parties, please be absolutely sure to include this user manual.

Explanation of symbols

The following symbols and signal words are used in this user manual, on the window cleaner or on the packaging.

 **WARNING!**

This signal symbol/word designates a hazard with moderate degree of risk which may lead to death or severe injury if not avoided.

 **CAUTION!**

This signal symbol/word designates a hazard with low risk that, if not avoided, may result in minor or moderate injury.

NOTICE!

This signal word warns against potential damages to property.



This symbol provides you with useful supplementary information on assembly or operation.



The mains adapter complies with protection class 2.



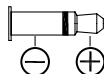

Safety

Proper use

The window cleaner is only designed for cleaning wet and smooth surfaces such as windows, mirrors and tiles. The window cleaner is not suitable for vacuuming up dust or small parts. It is only intended for private use and is not suitable for commercial use.

Only use the window cleaner as described in this user manual. Any other use is deemed improper and may result in damage to property or even personal injury. The window cleaner is not a children's toy.

The manufacturer or vendor accepts no liability for damage caused by improper or incorrect use.

Safety notes

WARNING!

Risk of electric shock!

A faulty electrical installation or excessive mains voltage may result in an electric shock.

- Before using the window cleaner, read the user manual carefully.
- Keep the user manual for future use. If you pass the window cleaner on to third parties, please be absolutely sure to include this user manual.
- Only connect the charger of the window cleaner if the mains voltage of the socket corresponds to the nameplate specification.
- Only connect the charger of the window cleaner to an easily accessible socket so that you can quickly disconnect the window cleaner from the mains in the event of a fault.
- Never use the window cleaner if it is visibly damaged or if the charger and its cord is faulty or damaged.
- All repairs, including the replacement of the charger, must only be carried out by the customer service or by technicians who are authorised to do so. Repair by unqualified persons could result in a risk of injury to the user.
- Do not open the housing; instead, have a qualified professional perform the repairs. Contact a qualified workshop for this. Liability and warranty claims are waived in the event of repairs performed by the user, improper connection of the device or incorrect operation.
- Only parts that comply with the original device data may be used for repairs. Electrical and mechanical parts, which are essential for providing protection against sources of danger, are located in this window cleaner.

- The charger of the window cleaner must not be operated with an external timer or a separate telecontrol system.
- Never immerse the housing of the window cleaner and the charger and its cord in water or other liquids. Clean them with a damp cloth.
- Never touch the charger with damp hands.
- Never pull the charger out of the socket by the mains cord; instead, always do so by taking hold of the charger.
- Never use the mains cord as a carrying handle.
- Keep the window cleaner, charger and its cord away from open flames and hot surfaces.
- Lay the charger cord so that it does not pose a tripping hazard.
- Do not kink the mains cord and do not lay it over sharp edges.
- Only use the window cleaner in indoor areas. Never operate it in wet rooms or in the rain.
- Never store the window cleaner such that there is a risk of it falling into a tub or a basin.
- Never reach to retrieve an electrical device if it has fallen in water. In such a case, immediately disconnect the mains plug.
- Make sure that children do not insert any objects in the window cleaner.
- Do not insert any objects which conduct electricity in the charging socket, e.g. a screwdriver.
- Do not use the window cleaner if battery fluid is leaking out of the window cleaner. Contact the manufacturer, its customer service or a similarly qualified person in this case.
- Only use the enclosed charger to charge the window cleaner.

⚠ WARNING!

Danger for children and persons with impaired physical, sensory or mental capacities (e.g. partially disabled persons, older persons with reduced physical and mental capacities) or lack of experience and knowledge (e.g. older children).

- This appliance can be used by children over the age of eight and by people with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, if they are supervised while using it or have been shown how to use it in a safe way and understand the hazards involved. This appliance may not be used as a plaything. Cleaning and maintenance can be performed by children only if properly supervised.
- Keep children under eight years of age away from the window cleaner and connector cable of the charger.
- Do not leave the window cleaner unattended while in operation.
- Do not allow children to play with the accessory parts of the window cleaner.
- Keep all packaging out of the reach of children do not allow children to play with the package wrapping. Children may get caught in it when playing and suffocate.
- When disposing of the appliance as waste, it must be made inoperative by cutting off the power cord. Also remember to make any of the potentially hazardous parts of the appliance safe, as there is a risk that children may use them as playthings.

NOTICE!**Risk of damage!**

Improper handling of the window cleaner may result in damage to the window cleaner.

- Never place the window cleaner on or near hot surfaces (e.g. hotplates).

- Make sure that the charger and its cord do not come into contact with hot or sharp surfaces.
- Never expose the window cleaner to high temperatures (heaters etc.) or to effects of the weather (rain etc.). Never fill the window cleaner with liquid.
- Never immerse the housing of the window cleaner, the charger and its cord in water or other liquids and do not use a steam cleaner to clean it. Otherwise, you could damage the window cleaner, the charger and its cord. Clean them with a damp cloth.
- Do not in any case place the window cleaner in the dishwasher. It would be destroyed as a result.
- Only use commercially-available glass cleaners for the window cleaner. Do not use spirit or foaming cleaners.
- Stop using the window cleaner if its plastic parts exhibit cracks, are chipped or are deformed. Only replace damaged parts with corresponding original spare parts.
- Do not aim the spray jet directly at devices containing electrical components.

First use

Checking the window cleaner and product contents

NOTICE!

Risk of damage!

If you are not cautious when opening the packaging with a sharp knife or other pointy object, you may quickly damage the window cleaner.

- Be very careful when opening.
 1. Take the window cleaner out of the packaging.
 2. Check to make sure that the delivery is complete (see **fig. A**).
 3. Check whether the window cleaner or the individual parts are damaged. If this is the case, do not use the window cleaner. Contact the manufacturer at the service address specified on the warranty card.

Charging the rechargeable battery

NOTICE!

Risk of damage!

Improperly charging the rechargeable battery may damage the rechargeable battery.

- Do not charge the rechargeable battery at temperatures below 5 °C or above 40 °C. Otherwise, you could damage the rechargeable battery.

Before first use, the rechargeable battery must be charged for 24 hours. The housing of the window cleaner **1** may become hot during the charging process.

1. Connect the charger **4** to the charging socket **11** of the window cleaner.
2. Connect the charger to a properly installed socket.

The rechargeable battery control light **12** will blink during the charging process. Once the rechargeable battery control light stops blinking, the rechargeable battery has been fully charged and the window cleaner is ready for use.

3. Remove the charger from the charging socket.

You can now use the window cleaner.

If the rechargeable battery control light starts blinking after a certain duration of use, the rechargeable battery has to be charged again. The window cleaner will automatically switch off when the rechargeable battery does not have enough power.



If the rechargeable battery life is very short after prolonged use, this is not a fault of the window cleaner. This can be resolved by

- using the window cleaner until the rechargeable battery has completely discharged and the operation is interrupted.
- recharging the window cleaner several times.

Should the rechargeable battery life nevertheless remain short, contact customer service.

Operation

Using the spraying attachment

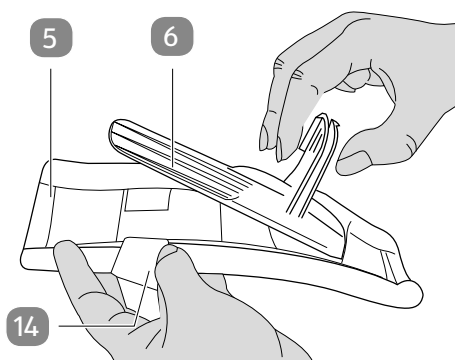
⚠ CAUTION!

Risk of injury!

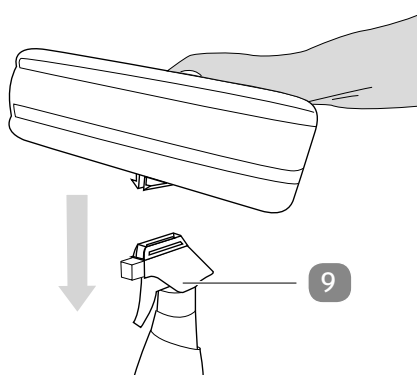
Improper handling of the sprayer may result in injury.

- Do not aim the spray jet at eyes.

1. Add 50 ml of commercially-available glass cleaner to the sprayer **8** and fill the sprayer up with clear tap water.
2. Insert the cloth holder **6** into the lateral pouch of the microfibre cloth **5** and attach the microfibre cloth with the Velcro fastener **14** to the cloth holder.



3. Push the cloth holder with the fastening clamp **7** onto the spray pistol **9** until the fastening clamp locks into place.
4. In order to clean the surface, push the trigger of the spray pistol and wipe over the surface with the microfibre cloth in semi-circular movements.

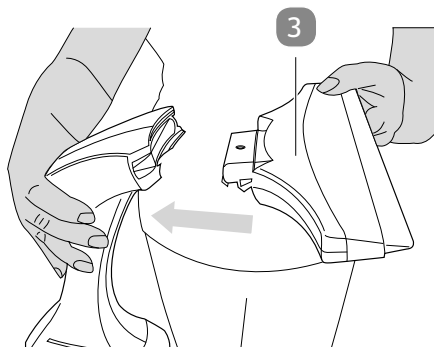


Using the squeegee

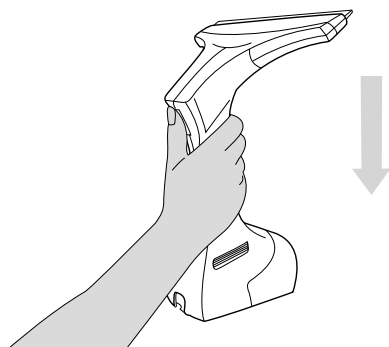


Do not perform semi-circular or horizontal movements when vacuuming the dirty water. Otherwise, water could leak out of the dirty water tank **2**.

1. Wet the surface with water or commercially-available glass cleaner.
2. Push the squeegee **3** into the window cleaner until the squeegee locks into place.



3. To switch on the window cleaner, push the On/Off button **10**.
4. Vacuum up the dirty water by gently pushing the squeegee against the surface and guiding the window cleaner slowly down from top to bottom, so that the rubber of the squeegee adheres to the surface.



Cleaning

NOTICE!

Risk of short circuit!

Water that has penetrated the housing may cause a short circuit.

- Never immerse the window cleaner in water.
- Make sure that no water penetrates the housing.

NOTICE!**Risk due to improper operation!**

Improper handling of the window cleaner may result in damage.

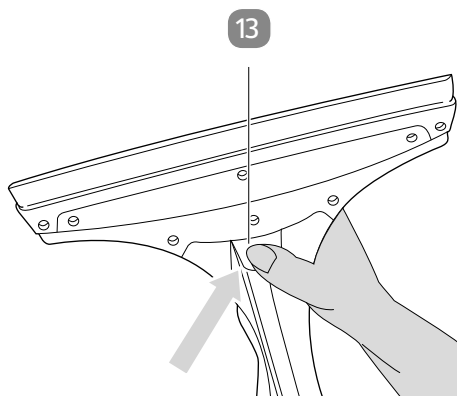
- Do not use any aggressive cleaners, brushes with metal or nylon bristles, sharp or metallic cleaning utensils such as knives, hard scrapers and the like. They could damage the surfaces.
- Do not attempt to clean the window cleaner and the accessories in the dishwasher. It would be destroyed as a result.

Cleaning the spraying attachment

1. To remove the cloth holder (6) from the spray pistol (9), press the fastening clamp (7) of the cloth holder together and pull the cloth holder off.
2. Remove the microfibre cloth (5) from the cloth holder.
3. Wash the microfibre cloth at 60 °C in the washing machine without adding softeners.
4. Wipe the cloth holder off with a damp cloth. Then let all parts dry completely.

Cleaning the squeegee

1. To remove the squeegee (3), push the clamping button (13).
2. Take the squeegee off of the window cleaner.
3. Rinse the squeegee out under running water.

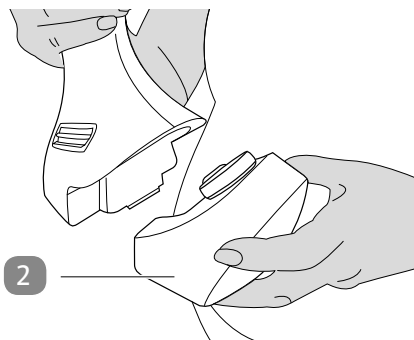
**Cleaning the window cleaner**

1. Pull the charger (4) out of the charging socket (11) before cleaning.
2. Let the window cleaner cool off completely.
3. Wipe the housing of the window cleaner (1) off with a damp cloth. Then let all parts dry completely.

Emptying the dirty water tank

Once the dirty water tank has reached its maximum fill level, it must be emptied.

1. To switch off the window cleaner, push the On/Off button **10**.
2. Remove the dirty water tank **2**.
3. Empty the dirty water tank and rinse it out with clear tap water.
4. Put the dirty water water tank back into the window cleaner.



Storage

- Store the window cleaner in a clean and dry area.

Disposal

Disposing of the packaging

Dispose of the packaging separated into single type materials. Dispose of cardboard and carton as waste paper and foils via the recyclable material collection service.

Disposing of old devices

(Applicable in the European Union and other European states with systems for the separate collection of reusable waste materials)

Old devices must not be disposed of with household waste!
